MIKHAIL AKULOV researches and writes on borderlands in the time of imperial decomposition—Ukraine and Central Asia, in particular. As a faculty member at Nazarbayev University in Astana, Kazakhstan, he teaches courses on Eurasia's "short 20th century" and is working on a manuscript on Ukraine as a field of political and social experiments during the last year of World War I.

NATALYA CHERNYSHOVA is Lecturer in Modern European History at Queen Mary University of London. She has published on Belarusian and late Soviet history, including *Soviet Consumer Culture in the Brezhnev Era* (2013) and, most recently, a chapter on the Soviet legacy in the 2020 Belarusian protests in E. Korosteleva et al., eds., *Belarus in the Twenty-First Century: Between Dictatorship and Democracy* (2023). She is currently writing a history of late Soviet Belarus under the leadership of Petr Masherau, a project supported by the British Academy Mid-Career Fellowship (2020–22).

MIKHAIL DOLBILOV is Associate Professor of History at the University of Maryland, College Park, and the author of *Russkii krai, chuzhaia vera: Etnokonfessional 'naia politika imperii v Litve i Belorusii pri Aleksandre II* (Russian Borderland, Foreign Faith: Imperial Ethno-Confessional Policy in Lithuania and Belorussia under Alexander II [2010]) and *Zhizn' tvorimogo romana: Ot avanteksta k kontekstu "Anny Kareninoi"* (The Life of a Novel in Progress: From Pre-Text to Context in *Anna Karenina*, 2023). His current book-length project, *The Ruling House as an Unruly Clan*, addresses the Russian monarchy's political legitimacy as it intertwines with the story of the Romanovs becoming a large dynasty throughout the 1860s–80s.

VLADIMIR HAMED-TROYANSKY, Assistant Professor of Global Studies at the University of California, Santa Barbara, is a historian of migration

and displacement in the Ottoman and Russian empires. His forthcoming book, *Empire of Refugees: North Caucasian Muslims and the Late Ottoman State* (2024), examines the resettlement of about a million refugees from the Caucasus in the Middle East and the Balkans. He is writing a new book on hijra, or Muslim refugee migration, in the Middle East, Central Asia, and South Asia since the mid-19th century.

Julie Hessler is Associate Professor at the University of Oregon, where she teaches Russian and Soviet history, 20th-century Europe, and food history. The author of *A Social History of Soviet Trade: Trade Policy, Retail Practices, and Consumption, 1917–1953* (2004) and co-author, with Robert O. Paxton, of the fifth edition of *Europe in the Twentieth Century* (2010), she is currently writing a book on the impact of non-Western cultural connections on Soviet intellectuals' creative and civic lives.

SHERZOD MUMINOV is Associate Professor of Japanese History at the University of East Anglia. His first book, *Eleven Winters of Discontent: The Siberian Internment and the Making of a New Japan* (2022), details the history of the captivity of 600,000 Japanese POWs in Soviet labor camps in the decade following World War II. He is currently working on a global history of Soviet sympathizers.

James Pickett, Associate Professor of History at the University of Pittsburgh, focuses on empire and Islam as entangled sources of authority, with particular attention to historical memory and state formation. His first book, *Polymaths of Islam: Power and Networks of Knowledge in Central Asia*, appeared in 2020. His next book project compares Bukhara's transformation into a Russian protectorate with the Indian princely state of Hyderabad's parallel trajectory into semi-colonial status.
